Trolley System

Recommendation:

That the December 2, 2005, Transportation Department report 2005TS2594 be received for information.

Report Summary

This report responds to an inquiry regarding the trolley system.

Previous Council Action

- At the January 17, 2006, City Council meeting, the December 2, 2005, Transportation Department report 2005TS2594 was referred to the January 24, 2006, Transportation and Public Works Committee meeting.
- At the November 15, 2005, City Council meeting Councillor K. Leibovici made the following inquiry:
 - "I recently met with the Edmonton Trolley Coalition. As a result of this meeting I have the following questions:
 - 1. What is the length of the lease from Vancouver for the new test trolley?
 - 2. When will the trolley(s) arrive?
 - 3. Has there been any research into obtaining new low-floor bus chassis and retrofitting the motors and updating the electronic controls into these shells? It is my understanding that Seattle has done this and it is common to do this in the trucking industry, where it's known as a "glider." The cost of retrofitting the motors is approximately half of that of buying a new low-floor trolleybus.
 - 4. As the power poles are still in existence to Northgate from downtown, is the extension of the trolley system being contemplated

- for the proposed High Speed Transit system or as part of Route 9?
- 5. As 102 Avenue still has express trolley wires, will trolley service be considered for the first stage Bus Rapid Transit alignment from the West End?
- 6. Has the department refused to put priority signals in any locations?"

Report

Question 1

Edmonton Transit has been in initial discussions with Coast Mountain Bus Company regarding a request to lease a trolleybus. Further discussions will also be required with TransLink, which is the regional authority that oversees public transit service in the greater Vancouver region. Ideally, we would lease and test this vehicle for a minimum period of six months.

Ouestion 2

Based on recent discussions with TransLink (Coast Mountain Bus), initial delivery of the new trolleybuses in Vancouver will begin in September 2006. TransLink requires a number of these buses to go into service immediately as replacement units for their aging fleet. It appears that the earliest time that a bus can be acquired for Edmonton is spring 2007.

Question 3

Edmonton Transit is investigating this option and will be in contact with Seattle related to their experience. However, key electronic components of Edmonton Transit's trolley bus fleet propulsion system are obsolete, with replacement parts not readily available from suppliers. Substantial re-engineering of the present propulsion

system on new low-floor bus shells would be required.

Question 4

The extension of the trolley system is being considered for trolleybus operation on Route 9 (Northgate to Southgate) and Route 134 (Northgate to downtown). The North BRT line is proposed to extend to 97 Street and 153 Avenue. In addition, consideration is being given to operating the North and Southeast BRT routes as a single line to improve cross-town connections and customer convenience travelling to major destinations.

Question 5

Trolleybus operation was not being considered for the West BRT alignment. Trolley overhead is not available to West Edmonton Mall and Lewis Estates. In the sections that do not have express wire, BRT vehicles could be delayed by local service unless a significant expenditure is made on new overhead infrastructure.

Question 6

Transit priority signals, which include bus activated signals and queue jump signals are funded from CPP Project XX-66-1220, which includes funding for full traffic signals, pedestrian activated signals, pedestrian amber flashers and transit priority signals. Each year, the department identifies a number of potential locations for transit priority signals. All identified intersections are evaluated for delays and operational impacts and prioritized for installation. Based on the evaluation process, some requested locations are not actioned.

The department has continued to provide new bus activated signals in the city (i.e. 37

Street/34 Avenue in 2004 and 35A Avenue/34 Street in 2005). Further, an additional investment in transit priority measures will be required in the future along major transit corridors.
